### 4.2 Paid Packages

We offer three service packages:

- "Kickstart" Package: Provides 10 credits
- "Accelerate" Package: Provides 30 credits
- "Launch" Package: Provides 75 credits

## 4.3 Credit Usage

Each credit enables full access to services for one job vacancy, including downloadable PDF versions of resumes and cover letters, and complete preparation plans.
